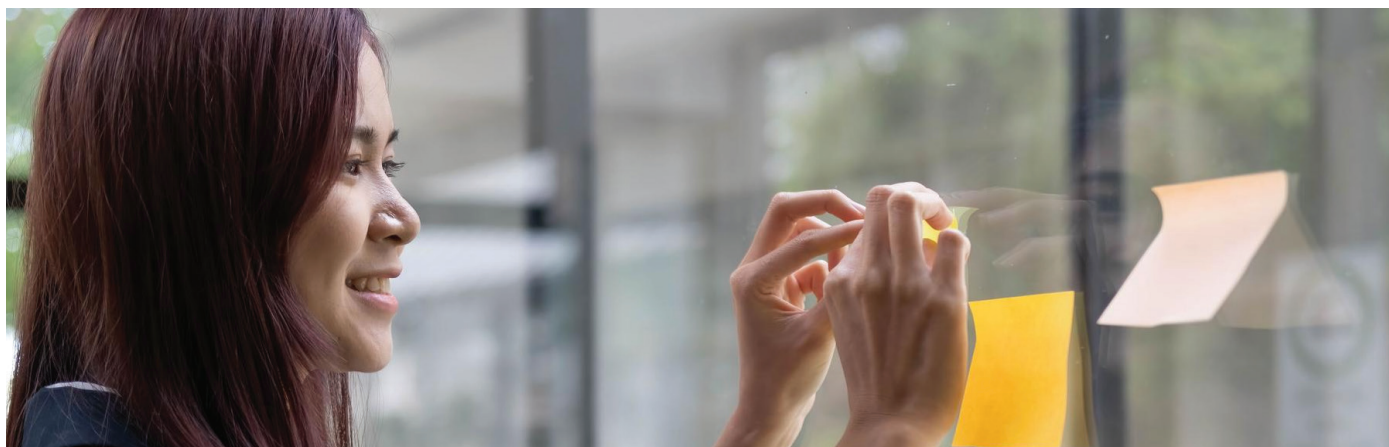

# Introduction

The International Accreditation Forum (IAF) and its Accreditation Body (AB) Members invest significant effort and resources to maintain the integrity and consistency of the IAF Multilateral Recognition Arrangement (MLA) through a peer evaluation process. This report sets out the detailed activities that are carried out as part of the peer evaluation process to ensure that regulators, specifiers, and businesses can have confidence in the MLA. The focus of this document is to report on the activities undertaken by IAF, in collaboration with ILAC, and the evaluation activities undertaken by these organisations or the Regional Accreditation Groups (RAGs). This report also outlines the activities of the IAF MLA Committee (MLAC) and the IAF MLA Management Committee (MLA MC) in collaboration with ILAC under the Joint Management Committee (JMC).



## The IAF MLA

The purpose of the IAF MLA is to provide users in countries with ABs that are IAF MLA signatories with the assurance that equivalent Certification Bodies (CBs) and Validation/Verification Bodies (VVBs) in other economies operate to the same standards as those in their own economies for certificates and statements in the fields of:



Accreditations granted by IAF MLA AB signatories are recognised worldwide based on their equivalent accreditation programmes, therefore reducing costs and adding value to industry and consumers.

The MLA contributes to the facilitation of world trade by eliminating technical barriers. IAF works to find the most effective way of achieving a single system to meet the objective of “Accredited once, accepted everywhere”.

# The IAF MLA Mark

The IAF MLA Mark can be used by ABs to demonstrate their status as a signatory to the IAF MLA. If approved by the AB, accredited CBs and VVBs can also use the IAF MLA Mark in combination with the accreditation symbol on their certificates or statements, provided that the certificates or statements are issued under a granted IAF MLA scope.

The IAF MLA Mark demonstrates that the certificate or statement has been issued by a CB or VVB that is accredited by an IAF MLA signatory and is thus traceable to the highest authority. It is an assurance that the certificate or statement and the issuing body are of a high standard of competence and may be trusted, as they are recognised as complying with the same set of standards at the global level.

# Changes in the Scope of the IAF MLA During 2024

In 2024, the IAF MLA continued its expansion with the successful endorsement of several new private sector schemes as sub-scopes under the Arrangement. The following schemes completed the endorsement process and were formally accepted into the MLA:

- IFS Logistics Certification Scheme V3
- BRCGS Ethical Trade and Responsible Sourcing Issue 2.1
- FSSC 24000 Certification Scheme
- GLOBALG.A.P. Integrated Farm Assurance (IFA) Version 6
- IFS PACsecure Version 3
- Friend of the Sea Certification Scheme (World Sustainability Organisation – WSO)
- IFS Broker Version 3.2

Several other schemes remained under evaluation in 2024, with the intention of achieving approval in 2025:

- Interprivacy Certification Scheme (European Centre for Certification and Privacy – ECCP)
- IFS Wholesale and Cash & Carry Version 3 Standard

Applications for new schemes received during 2024:

- IAF received two new scheme owner applications during 2024, which are currently under review.

New versions of existing schemes received in 2024:

- BRCGS Global Standard - Packaging Material Issue 7

As part of ongoing efforts to enhance transparency and accessibility, the MLAC has launched a new dedicated webpage for IAF-endorsed schemes. This resource, developed by the CMC Chair in collaboration with the IAF Secretariat, provides up-to-date information on endorsed schemes and can be accessed at: <https://iaf.nu/en/endorsed-schemes/>.

Regarding public sector schemes:

- ISO 37001: Anti-bribery management systems – Requirements with guidance for use and ISO 37301: Compliance management systems – Requirements with guidance for use. Both were approved for inclusion in the IAF MLA following a ballot by IAF members in December 2024.
- OIML Certification System. Remains under discussion and has not been accepted as of this report.

# Transitions

Throughout 2024, the IAF continued overseeing and managing multiple transitions to updated standards to ensure consistency, reliability, and alignment across regions. These transitions are implemented according to IAF resolutions and are overseen by the IAF MLA Management Committee (MLA MC) and the Joint Management Committee (JMC).

- European co-operation for Accreditation (EA)
- Inter American Accreditation Cooperation (IAAC)
- Southern African Development Community Cooperation in Accreditation (SADCA)

Membership in the IAF MLA is facilitated through participation in a recognised RAG's MLA for the relevant programs. IAF members who are also signatories to regional MLAs may be accepted into the IAF MLA for those same programs.

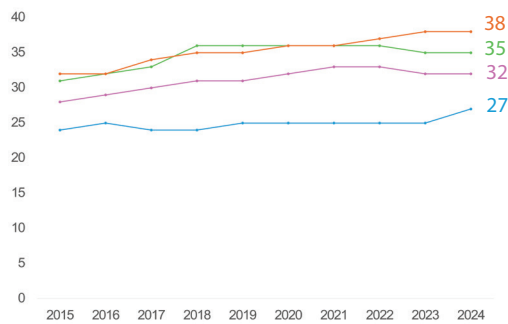

Certification of Management System

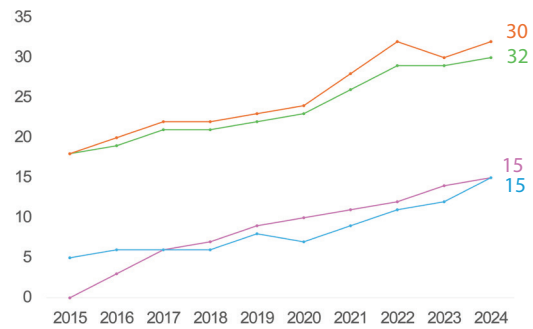
Number of signatories for

Certification of Persons

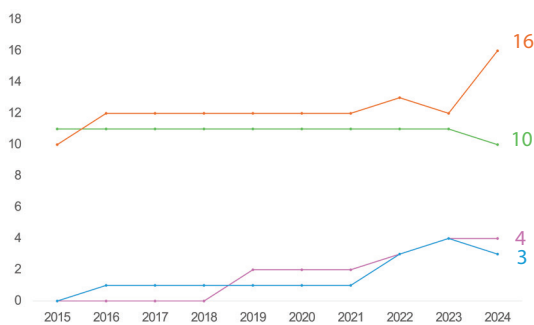
Number of signatories for GHG  
Validation/Verification



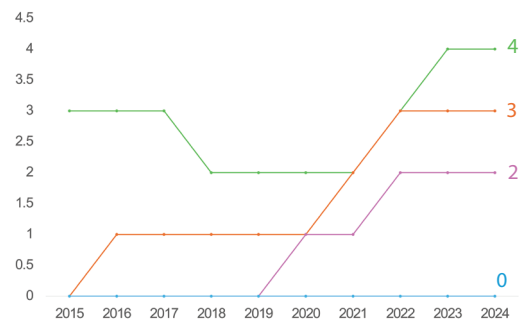
European co-operation for Accreditation



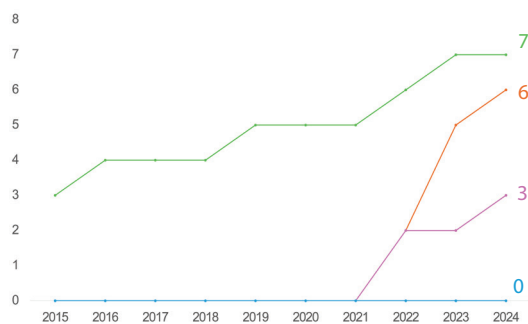
Asia Pacific Accreditation Cooperation



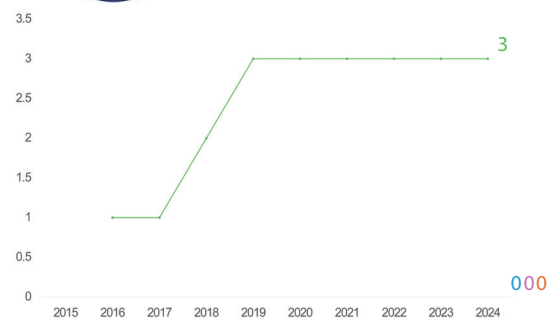
Inter American Accreditation Cooperation

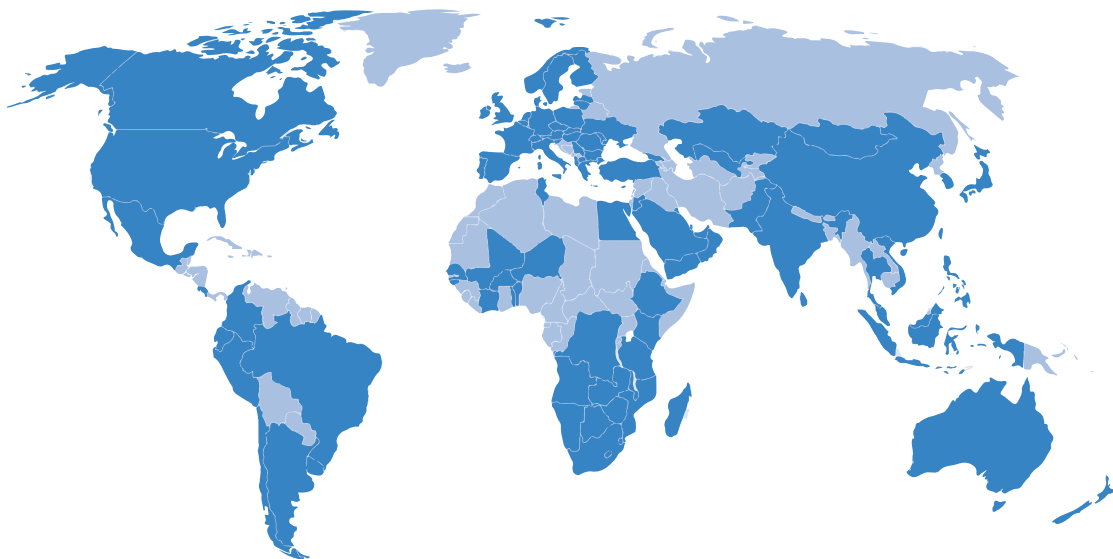

In 2024, the IAF MLA comprised six recognised RAGs and 86 ABs, representing a total of 100 economies.





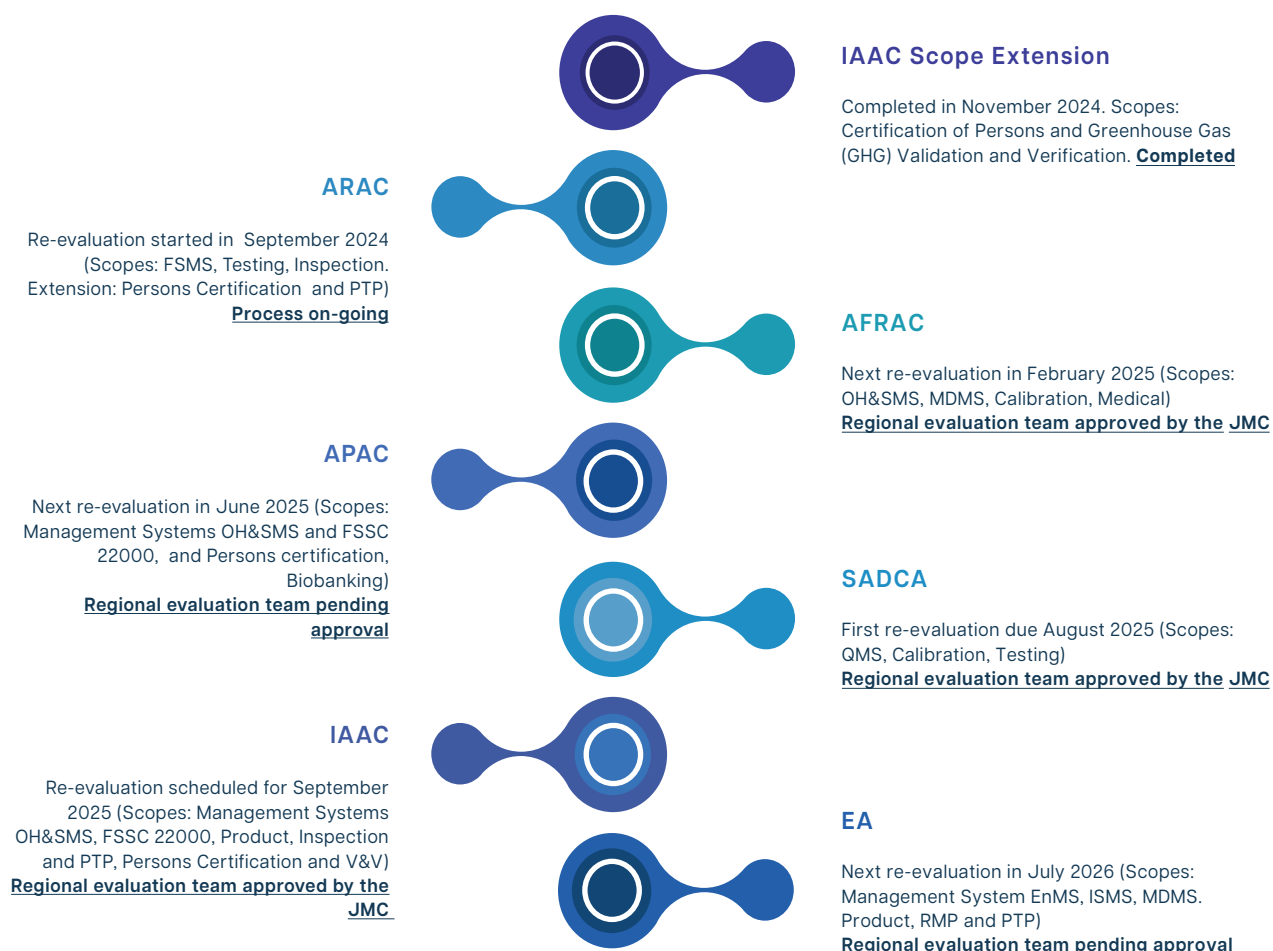
# Peer Evaluation Activities

Accreditation Bodies (ABs) are admitted to the IAF MLA only after undergoing a rigorous peer evaluation process. This process is conducted by a qualified evaluation team tasked with verifying that the applicant fully complies with applicable international standards and IAF requirements.

IAF and its AB members dedicate significant resources and effort to ensure the continued credibility and integrity of the MLA through these robust peer evaluations. The Arrangement and its signatories are subject to ongoing scrutiny, with evaluations conducted regularly across all participating economies.

The peer evaluation process is comprehensive, systematic, and essential to maintaining global confidence in the MLA.

# IAF MLA Improvement Activities

IAF remains committed to continually monitoring, evaluating, and enhancing the IAF MLA to ensure it continues to meet stakeholder needs and expectations. In pursuit of this commitment, IAF regularly consults with stakeholders and undertakes targeted initiatives and improvement programs to strengthen the effectiveness, reliability, and global value of the MLA.

# Feedback

Complaints provide a valuable mechanism for receiving feedback relating to the effectiveness of the MLA. This often confirms that the MLA is working effectively and that the process in place is suitably robust. It can also provide information that can be used to improve areas of the MLA. During the reporting period, the following complaints were received and processed:

## Complaints referred to ABs



8 received and were closed on 31 December 2024

## Complaints referred to RAGs



3 received and were closed on 31 December 2024

These figures reflect IAF's ongoing commitment to transparency, responsiveness, and continual improvement across the MLA framework.

## Improvement Activities

IAF remains dedicated to enhancing the effectiveness, credibility, and value of the IAF MLA. This includes wide-ranging stakeholder engagement, continual refinement of procedures, and close collaboration with ILAC through the Joint Management Committee (JMC), which oversees all peer evaluation activities.

### • Collaboration with ILAC through the JMC

In 2024, IAF and ILAC continued to coordinate all peer evaluation matters through the JMC. By eliminating separate meetings of the IAF MLA Management Committee and the ILAC Arrangement Management Committee, the JMC fosters more efficient decision-making and harmonized practices.

# Key JMC Initiatives in 2024:

- **Revisions of Foundational Documents:**

The JMC progressed in revising **IAF/ILAC A1** (evaluation of Regional Accreditation Groups) and **IAF/ILAC A2** (evaluation of individual Accreditation Bodies), incorporating feedback from a 2023 workshop and integrating risk-based evaluation principles.

- **Evaluator Training Program for Regional Accreditation Group Evaluations:**

In 2024, the JMC Training Task Force Group (TFG) made significant progress in developing a comprehensive training program for evaluators involved in the assessment of RAGs. The objective is to ensure consistency, competence, and alignment in peer evaluations conducted under the IAF/ILAC framework. This initiative reinforces the commitment of IAF and ILAC to capacity-building and quality assurance in peer evaluations, particularly at the regional level, and will be instrumental in supporting a consistent approach under the forthcoming unified global accreditation structure.

- **Strategic Alignment Meetings:**

The JMC convened virtually in April and in person in October 2024 to discuss procedural improvements, aligned reporting formats, and preparation for the Global Accreditation Cooperation Incorporated framework. The meetings reinforced the shared direction between IAF and ILAC as they advance toward integration.

- **Highlights from the 22nd Meeting of the MLAC – Berlin, 4 October 2024**

The 22nd meeting of the IAF Multilateral Arrangement Committee (MLAC) brought together delegates from RAGs, ABs, and key stakeholders. Discussions focused on improving the structure and functioning of the MLA in alignment with future integration under the Global Accreditation Cooperation Incorporated.

### Progress of TFGs:

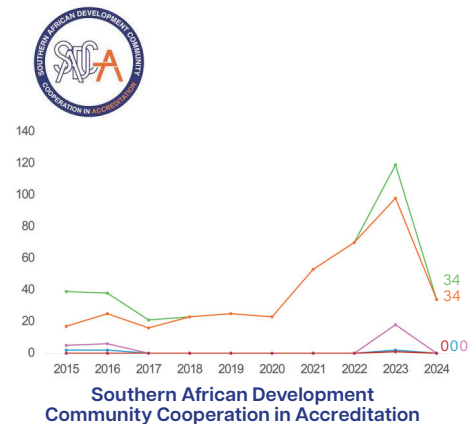
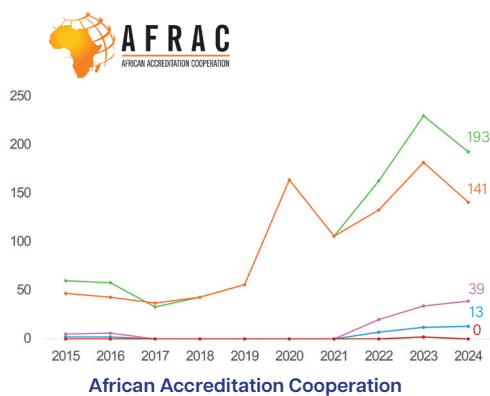
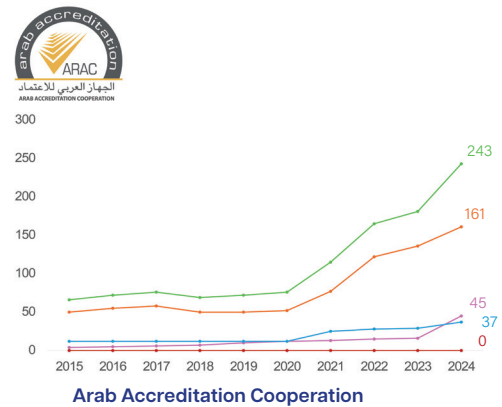
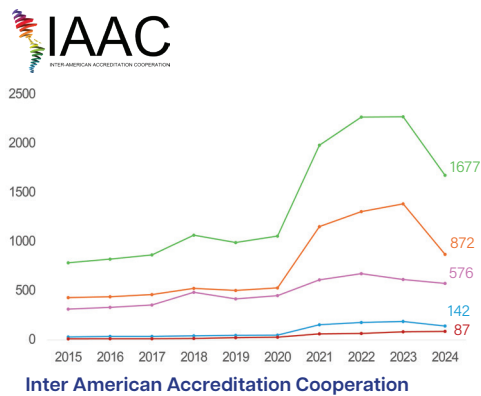
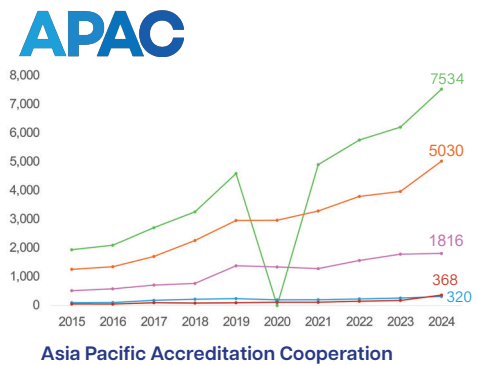
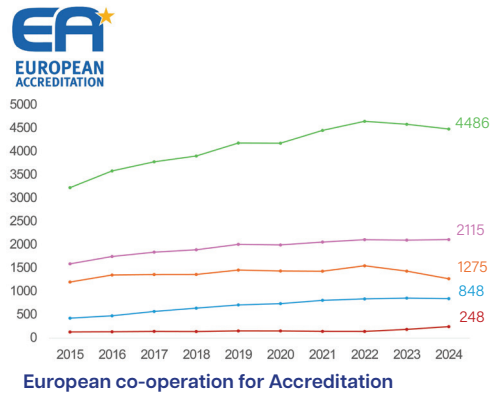
- Improving the MLA Scope Extension Process: A proposal was made to integrate IAF MD 25 elements into IAF PL 3 to simplify scope extensions, improve transparency, and establish clearer thresholds for international relevance.
- Addressing AB Cooperation: A unified cooperation document was drafted to consolidate existing IAF and ILAC principles, aiming to reduce inconsistencies and enhance collaboration among ABs.
- Revision of IAF ML4: Updates include clarified evaluation procedures, conflict of interest handling, and withdrawal of outdated annexes. The revision aligns IAF practices with ILAC policies and anticipates the Global Accreditation Cooperation Incorporated structure.

### Looking Ahead – MLAC Priorities for 2025:

- Revise **IAF PL3** to streamline MLA scope extensions.
- Finalize a consolidated **cooperation framework** to improve AB collaboration.
- Publish the updated **IAF ML4**, reflecting current practices.

# Global Growth

In addition to the growth in signatories to the IAF MLA, there has been a corresponding growth in the number of accredited CBs and VVBs.



**A total of 14,167 CBs and VVBs are currently accredited, an increase of 4% since 2023.**

Note: These numbers reflect the total number of sub-scopes covered by accredited CABs in the RAGs, including where a CAB is accredited for more than one sub-scope.

# Annex 1 – Scope of the MLA

The scope of the IAF MLA as of the end of 2024 is structured across five hierarchical levels:

- Level 1: Specifies the normative standard for Accreditation Bodies (ABs), currently ISO/IEC 17011:2017.
- Levels 2 and 3 (Main Scope): Defines the accreditation programs (e.g., product, management systems, personnel, validation and verification) and the associated normative documents endorsed.
- Levels 4 and 5 (Sub-Scope): Includes applicable sector-specific documents (Level 4) and associated certification or scheme requirements (Level 5).
