



# IAF and FoodPLUS Scheme Endorsement Agreement

#### 1. Introduction

- 1.1 The FoodPLUS is the scheme owner of the worldwide operated GLOBALG.A.P. schemes. FoodPLUS (hereinafter referred to as GLOBALG.A.P.) has sought and received endorsement of their schemes listed in Schedule 1 to this Agreement (hereinafter referred to as "the Schemes") as IAF MLA sub-scopes in accordance with IAF PL3 and this Agreement.
- 1.2 The Schemes require Certification Bodies (CBs) operating in the Schemes to be accredited by an Accreditation Body (AB) that is a signatory to the IAF Multilateral Recognition Arrangement (MLA) with a main scope of product certification and a sub-scope of the relevant scheme(s) included in Schedule 1 to this Agreement (IAF MLA signatories).
- 1.3 GLOBALG.A.P. sets voluntary standards for the certification of agricultural products around the globe. The aim is to establish ONE standard for Good Agricultural Practices (G.A.P) with different product applications capable of fitting into the whole of global agriculture. GLOBALG.A.P. is supported by 54 Retail & Food Service Community Members, 184 Producer & Supplier Community Members, and 214 Associate Community Members.
- 1.4 GLOBALG.A.P. contracts at the time of this Agreement with 194 CBs worldwide under the Schemes, the supervision of which is carried out by the ABs that are IAF MLA signatories.
- 1.5 The GLOBALG.A.P. requirements for the professional competence of personnel auditors are defined in the relevant scheme General Regulations.
- 1.6 GLOBALG.A.P. delegates the responsibility of supervision of the CBs it contracts with to the corresponding IAF Accreditation Bodies, noting that harmonization of criteria applied by the different ABs is increasingly important to ensure consistency of that supervision.
- 1.7 The Schemes provide the standard and framework for independent, recognized third-party certification of processes associated with the scope of the Schemes.

- 1.8 The **International Accreditation Forum (IAF)** is the world association of conformity assessment accreditation bodies in the fields of management systems, products, services, process, persons, validation and verification and other similar programs of conformity assessment.
- 1.9 IAF is responsible for the harmonization and continuous improvement of the accreditation practices of its members with the ultimate goal to ensure sound technical competence of accredited CBs and V&VBs (Validation and Verification Bodies) and to support its IAF MLA.
- 1.10 The IAF MLA is established and maintained based on the requirements of ISO/IEC 17011 through regular peer evaluations and is the tool by which IAF contributes to the elimination of technical barriers to trade and to promoting the free circulation of certificates issued by accredited CBs and V&VBs.

#### 2. Administration and Cooperation

- 2.1 Both IAF and GLOBALG.A.P., by means of this formal Agreement, have decided to develop and maintain a close cooperation between the two organizations to ensure harmonization in the accreditation practices performed by IAF members for the Schemes and to cooperate in the continuous improvement of the Schemes with the final goal of assuring the highest level of competence in the Schemes' accredited CBs.
- 2.2 IAF and GLOBALG.A.P. shall comply with the respective requirements of IAF PL3 Policies and Procedures on the IAF MLA Structure and for Expansion of the Scope of the IAF MLA, operating and administrating in an open, non-discriminatory and transparent manner, avoiding conflicts of interest or limitation on the acceptance of CBs or ABs other than relevant technical considerations.
- 2.3 The Schemes will be open to all CBs that are accredited by IAF MLA signatories. The ABs will be signatory members of the IAF MLA for product and have agreed to implement the requirements as per the IAF/GLOBALG.A.P. MoU. A list of IAF ABs that have agreed to implement the IAF/GLOBALG.A.P. MoU shall be maintained on the GLOBALG.A.P. website.
- 2.4 GLOBALG.A.P. will only work with IAF MLA signatories and who have agreed to implement the IAF/GLOBALG.A.P. MoU. GLOBALG.A.P. will stop working with an AB that is no longer a signatory to the IAF MLA or has not implemented and maintained the IAF/GLOBALG.A.P. MoU.
- 2.5 Both IAF and GLOBALG.A.P. shall appoint a liaison person of each organization to act as contact persons.

#### 3. Information Exchange

In order to achieve such goals, both organizations have agreed upon the following:

- 3.1 GLOBALG.A.P. shall inform the IAF of the following:
  - a) Changes to any of the schemes listed in Schedule 1, that may impact compliance with IAF PL3.
  - b) Any revision/extension of the Schemes' standards/documents.
  - Outcomes from any AB workshop held by GLOBALG.A.P. on one or more of the Schemes.
  - d) Feedback GLOBALG.A.P. may have regarding the IAF MLA signatory ABs.
  - e) Change in the status as Global Food Safety Initiative (GFSI) recognized scheme(s).
- 3.2 IAF shall inform GLOBALG.A.P. of the following:
  - When an IAF MLA signatory with a sub-scope of one or more of the Schemes has been suspended or had their IAF MLA signatory status withdrawn.
  - b) Any general or technical questions regarding the interpretation of the Schemes' standards/documents.
  - c) Changes in policy, procedure or documentation that may have an impact on the IAF MLA and Scheme sub-scope.

#### 4. Mandatory Interpretation of the Scheme Documents

- 4.1 The Schemes' documents shall be prepared using the GLOBALG.A.P. procedure for the setting and revision of Schemes' documentation. This shall include a stakeholder consultation phase comprising of comment submissions by interested parties each lasting a specified timeframe with feedback being provided to organizations that made the comment.
- 4.2 The IAF will be included as a stakeholder and invited to provide comments during any stakeholder consultation period of the Scheme revision process.
- 4.3 The Scheme normative documents shall be available free of charge on the GLOBALG.A.P. website (www.globalgap.org).
- 4.4 GLOBALG.A.P. will provide new draft Scheme version document(s) with a gap analysis and proposed transition plan for implementation of the new version documents to IAF as soon as a technically sound new version is available, in order to make sure that the new scheme version continues to comply with the requirements of IAF PL3. GLOBALG.A.P. accepts the process to be followed according to IAF PL3 for IAF MLA sub-scope inclusion of new versions of the Schemes.

- 4.5 The need for the development of specific IAF application documents for inclusion of publicly owned standards/normative documents in the IAF MLA shall be proposed by the IAF Technical Committee and the need for additional preparation of peer evaluation by the IAF MLA Committee as specified in IAF PL3.
- 4.6 The Schemes endorsed as IAF MLA sub-scopes are included in the relevant IAF MLA status lists. After the end of the transition period to a new scheme version the old version will not be published as IAF MLA sub-scopes anymore.

#### 5. Implementation

- 5.1 IAF and GLOBALG.A.P. shall each bear their own costs.
- 5.2 The Schemes will be included as a sub-scope under the main scope of product certification, ISO/IEC 17065. Those ABs currently providing accreditations to one or more of the Schemes will be able to apply for an IAF MLA scope extension for the relevant scheme(s) through provision of a signed self-declaration once this Agreement is signed.
- 5.3 The revision of the implementation of this Agreement is in the scope of the MLA Peer evaluation to the IAF product certification MLA signatories working in one or more of the Schemes that have agreed to implement the IAF/GLOBALG.A.P. MoU.

#### 6. Confidentiality

6.1 IAF shall hold all Confidential Information in strictest confidence and shall only use it for the purpose for which it was provided and shall not disclose or make available any Confidential Information to any third party without the prior written consent of GLOBALG.A.P.

#### 7. Term

7.1 This Agreement shall commence from the original Date of Signing and, unless terminated earlier according to clause 8, continues indefinitely.

#### 8. Cancellation

8.1 This Agreement between GLOBALG.A.P. and IAF can be cancelled by either party in writing with a period of notice of three months.
